According to recent surveys, more than 50 percent of business executives cite systemic or geopolitical risks as the greatest challenges facing their businesses, yet these challenges are still those which companies are the least prepared to manage. In order to thrive in the current globalised system, business leaders need to enhance their awareness of the impact of geopolitics.

COURSE BENEFITS

This course equips modern business leaders with the analytical skills you need to help you make sense of current geopolitical developments.

The course enables you to:

- · use simple concepts to analyse current events
- adopt a dynamic understanding of geopolitical developments
- assess the impact of geopolitical developments on your business and operations
- evaluate the opportunities and dangers of doing business abroad

COURSE FOCUS:

This course introduces the participants to simple analytical concepts within international relations, reviewing historical geopolitical developments in regional areas - Europe and Northern America, Asia, Africa and the Middle East. The focus is then on specific geopolitical issues that have an impact on businesses, such as cyber security, economic and political sanctions, and terrorism. The course ends with a practical course exercise looking at the impact of geopolitics on specific companies.





Course Director

Dr Jean-Marc Rickli is the Head of Global Risk and Resilience at the GCSP. Prior to his current appointment, he was assistant professor at the Department of Defence Studies at King's College London He is the co-chairman of the working group on emerging security challenges of the NATO Partnership for Peace Consortium. He is also an advisor to the Al Initiative of the Future Society at Harvard Kennedy School. He has a PhD in international relations from the University of Oxford.
